- Feedback on Real Christmas tree last year was negative so good reason for a change, and after the one off purchase cost of artificial tree, the annual cost of storage and

transport is effectively netted off by not buying a real tree therefore there's a neutral annual cost ongoing.

Members considered the request for new changing facilities to be installed on Whaley Common Recreation Ground.

It was **RESOLVED** to recommend utilising the earmarked reserve fund toward providing a modular changing facility at Whaley Common subject to consultation with residents and to explore any match funding available
